

How to Register for the Auer Steel Claim Portal

OVERVIEW

This document is designed to guide you through the registration process for the Auer Steel Claim Portal. The individual who completes the initial setup will be designated as the primary user. We recommend that the owner or a member of the senior management team complete the registration. Additional users can be added later to submit claims on your behalf.

Step One - Get Started: Go to https://auersteel.distributorprograms.com/ and select

Register/Submit Claim

INCENTIVE PORTAL

After completing the installation, submit your incentive claim via the portal, along with your Auer Steel invoice. Approved applications will receive a credit from Auer Steel. If you haven't yet enrolled as a participant, be sure to do that first.

Step Two - *Register Now:* To create an account, enter your email address and create a password. Click 'Register Now'.

Step Three - *Company Profile:* To get started, enter your Auer Steel customer ID number. Next, fill in your business address and ZIP code; the city and state will populate automatically. Complete the remaining fields in the form, then select your primary branch name from the dropdown menu—this will auto-fill the branch details. Lastly, under Program Participation, check the boxes for the programs you'd like to enroll in.

A password will be sent to the email provided. This allows multiple users to submit rebate applications and track the status of pending claims.
